Information notice on personal data processing pursuant to articles 13-14 of EU Regulation 2016/679

EU regulation 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of data subject

- 1. The data subject shall have the right to obtain from the data controller confirmation as to whether or not their personal data are being processed, even if they have not yet been registered, their communication in an intelligible form as well as to file a complaint with the Supervisory Authority.
- 2. The data subject has the right to be informed about:
 - a. the source of personal data;
 - b. purposes and methods of data processing;
 - c. criteria applied if processing is carried out with electronic systems;
 - d. the personal details of the Data Controller, Processor and Representative appointed pursuant to article 5, section 2;
 - e. subjects or categories of subjects to whom the personal data may be transmitted or who may become aware of them in their capacity as designated representative in the territory, data processors or persons in charge of data processing.
- 3. The data subject has the right to:
 - a. update, rectify or integrate the data, if necessary;
 - b. erasure, anonymization, blocking of data that have been processed unlawfully, including data whose retention is unnecessary for the purposes for which they have been collected or subsequently processed;
 - c. a certification attesting the activities as per letters a) and b) have been notified, as also related to their contents, to the entities to whom the data were transmitted or disseminated, unless such fulfillment proves impossible or involves disproportionate effort compared to the safeguarded right.
 - d. data portability.
- 4. The data subject has the right to object, in all or in part:
 - a. processing of their personal data for just cause even if they are relevant to data collection;
 - b. processing of their personal data if the purposes of data processing is to send advertising materials or direct selling material or to conduct market or commercial communication surveys.
